#### YQCA Certification



One of the requirements for those who plan to participate in the Kansas State Fair Grand Drive and/or KJLS is that ALL exhibitors are required to complete Youth for the Quality Care of Animals (YQCA) certification to be eligible for either show in 2024.

#### FOR ELK COUNTY 4-H/FFA MEMBERS:

Each 4-H/FFA member that wishes to sell animal(s) in the livestock premium sale at the county fair must complete YQCA certification training before **July 1**. Members may complete an online course or attend a face-to-face training. Once you complete a training, members will receive a certification number. That information will need to be forwarded to Stephanie Bogdahn.

#### Families Needed for Hosting Japanese Delegates

More host families are needed for this exciting opportunity of hosting a Japanese delegate this summer. Eleven girls and six boys still need **Kansas homes.** The Japanese delegate will be in Kansas from July 21 – August 15, but host families are needed for July 23 – August 15. The 17 Japanese youth are between 12 – 16 years of age.

Any Kansas 4-H family with children aged 10-16, who are interested in the Japanese culture, may host. A separate bed is required, but not necessarily a separate room from the host sibling. Delegates are 100% medically covered with 4-H insurance and bring their own spending money for souvenirs. The delegates can go on host family vacations, camping trips, or join their host sibling for summer camps and the county fair. The focus is everyday family life.

**Benefits:** Increase your family's cross-cultural and global understanding, broaden family communication skills, make a new friend from another country, and have fun while leaning about Japan in your own home.

How to apply: Families may now apply on-line by visiting: <a href="https://www.states4hexchange.org/apply/h">https://www.states4hexchange.org/apply/h</a> ost. There is a required application with references. In addition, there will be an in-home interview conducted as well as background checks conducted for all adults living in the household.

What you do: The host family treats the delegate as a family member (rather than a tourist/guest) and keep a "regular" family schedule. That could mean chores, fairs, camping, ballgames, etc.... very busy – or not so busy. It just depends on what your family likes to do! Most delegates will have studied English for one year in school. They are usually shy and don't want to make mistakes –so the first few days getting them to talk may be a challenge! The host family needs to be pro-active on ways to communicate without words, or using a Japanese/English translation dictionary, etc.

State Livestock Nominations

The 2024 information for state livestock nominations has been released. The process transitioned to an online system in 2022, so there are no longer physical forms for families to complete and mail. Families will purchase DNA envelopes in advance, submit their animal and exhibitor information online, then mail their completed and signed DNA samples by the deadline. Extension Agents and FFA Advisors will approve nominations online. Exhibitors who nominated animals last year (in 2023) need to use their existing ShoWorks account. Those who need help accessing their account may request a password reset through ShoWorks or contact the Youth Livestock Program for assistance. Returning exhibitors should not create a new account.

All market animals and commercial females that youth would like to be eligible for the Kansas State Fair Grand Drive and/or KJLS must be nominated. Small Animals due by June 15. The deadline to order DNA envelopes is June 5 for small animals.

Fairbooks, Fair Entry Forms

Fairbooks and fair entry forms are now available for clubs and/or families to pick up at the Extension Office. 4-H/FFA fair entries are due Monday, July 1 by 4:00 p.m. in the Extension Office.

There are two Fashion Revue forms that must be completed for each entry. One is the information

and judges form and the other is the script. Both forms need to be completed and returned to the Extension Office by July 8! On the information and judges form, please attach a picture of you and your outfit.

If families are planning to exhibit beef, sheep, goats or swine, there is a livestock stall request to complete that is **due July 1.**

Put everything you might bring to the fair on your entry form. ABSOLUTELY NO ENTRIES WILL BE ACCEPTED AFTER JULY 1. Entries can be emailed or faxed to the Extension Office as well, but they still must be here by 4:00 p.m. on July 1. We will drop entries from the records if they do not check in at the fair, but we will not add entries at the fair.

Photo mats are available from the Extension Office for \$2.00 each. This includes a large Ziploc bag to place your completed project in.

Be sure you look over the fair schedule closely so you do not miss anything. If you have any questions about the fair, entries, shows or anything else you see in the fair book or newsletter, just ask us at the Extension Office!

Know your exhibit requirements. Read the fairbook. It is the exhibitor's responsibility to know the exhibition rules. Not being told is not a valid excuse for lack of personal responsibility.

Lost Ear Tags

If ear tags are lost from your market animals, they must be replaced! All market animals must have the proper ear tag in place to check in at the fair. So, whether you lost a tag on April 27 or July 17 let the office know ASAP to get it replaced.

4-H Record Books and Achievement Pin Applications

Entries are due August 15. For more information, contact the Extension Office.


Kansas 4-H Thrive Evaluation

In early June, Kansas 4-H will be conducting a 4-H Thriving Model evaluation. Members in grades 3 and up will be invited to participate in a survey to tell us about their experience in 4-H. The survey is designed to help Kansas 4-H understand how youth are thriving in 4-H. While the survey is optional, we would love to hear from every member.

Emails will be sent to the parent emails we have on file in 4-H Online with an electronic survey link. Parents will be asked to share the electronic survey link with their child(ren).

Here are some key things to know:

- The goal is for the first survey to go out the week of June 9. Two reminders will be sent to all participants who have not completed the survey. The survey will close mid-July.
- This data will help us share the impact of 4-H programs in Kansas. By responding, your child(ren) will help us tell the story of Kansas 4-H.
- If you do not want your child(ren) to participate in this study, you can simply delete the message. There is no impact on 4-H programming, and Extension Agents will never know who completed and who did not complete the survey.


